

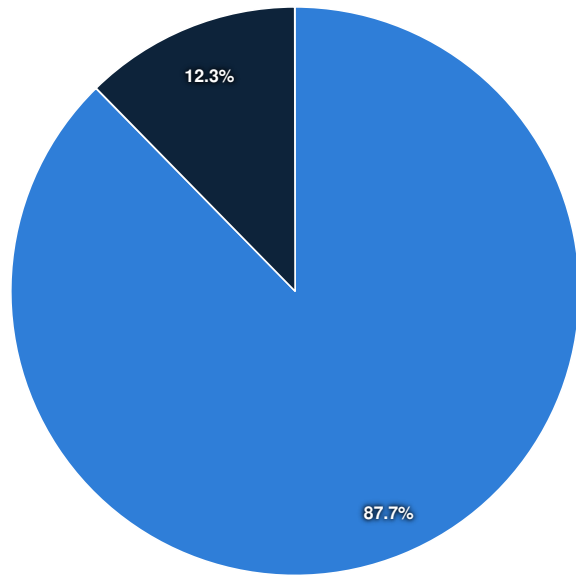

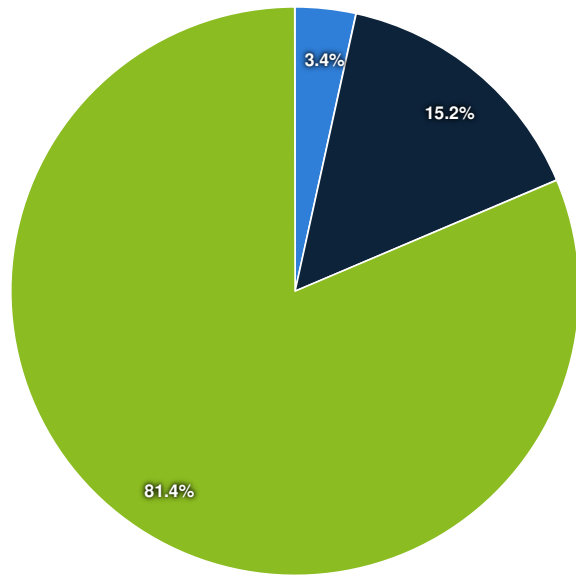
11A Did you attend the session - Brain Death Bioethics: Fundamental Principles and Emerging Issues?

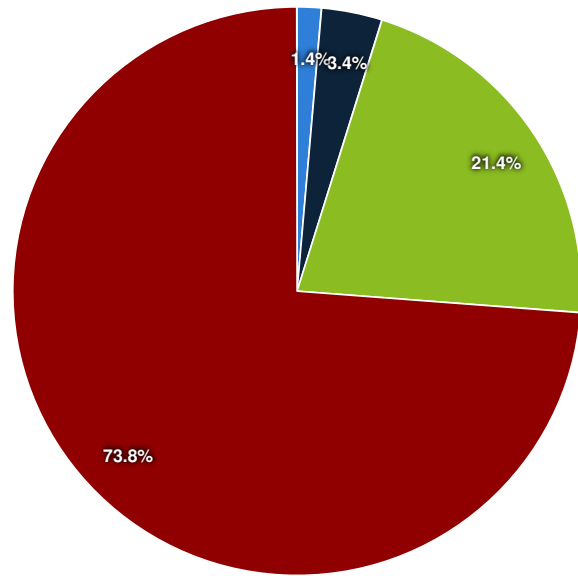

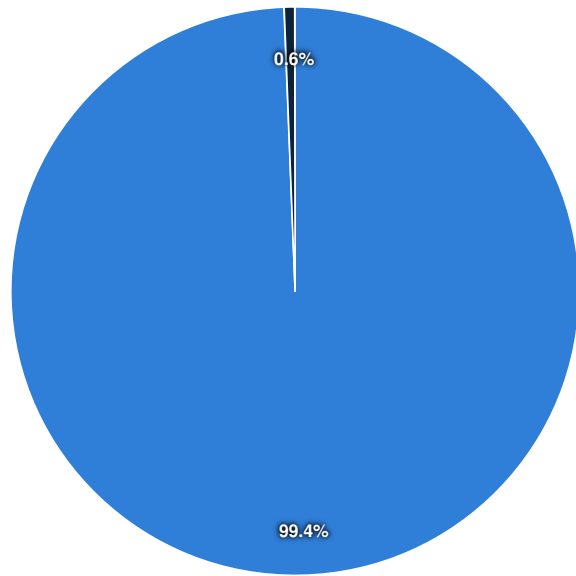
11C What is your overall rating of the value of Thaddeus Pope's presentation?

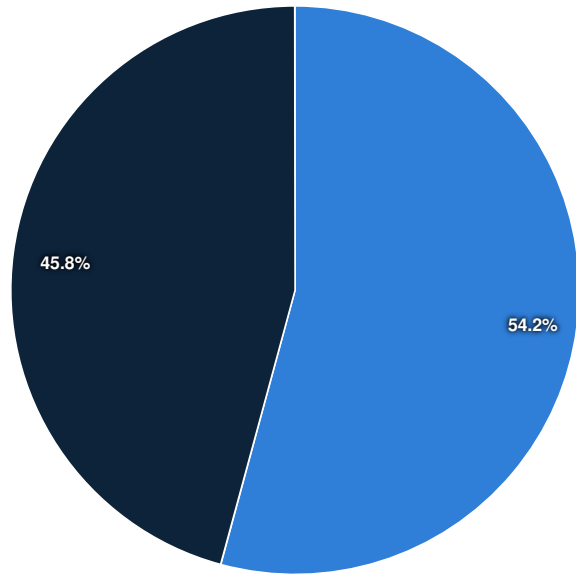

Very diverse group of speakers and topics. The conference overall would be improved by creating space for more interaction with attendees. This could be prompted by the speakers, and also the set-up, perhaps with having small tables rather than 'auditorium' seating. There seemed to be less networking between teams than I have observed at other sessions in the past.

Dr. Campbell's workshop was even more helpful than I expected; I plan to utilize his teaching frequently in my every day practice. Dr. Byock's talk was interesting, but not very applicable to my work; I wish it had been an optional session, because I question how useful it was for most RNs/Chaplains/SWs. The sleep disturbances lecture was interesting and informative, but I wish he had spent a little bit more time on interventions. The nutrition/hydration lecture armed me with a lot of good information, and I appreciated their nuanced approach to how to navigate the decisions with patients.

However, both the ANH and Sleep presentations defined the scope of the problems and issues but gave little in the way of actual practice advice. There is certainly a balance to strike wherein it's not all clinical or provider focused. But so many of the attendees are very familiar with these topics already and are more looking for current evidence-based treatments (or communication techniques, etc.) rather than definition of what ANH is (for example).
